### **MnSEIA's 2023 Legislative Priorities**

**Modernize Community Solar Garden Program (Rep. Acomb) -** Until 2022, Minnesota was #1 in the U.S for the largest CSG program! We aim to update Minnesota's community solar garden program by:

- Removing arbitrary contiguous county geographic restriction
- Increasing project size from 1 to 5 megawatts
- Improving residential access and diversifying subscribers to solar gardens.

**Accelerate the Energy Storage Market -** Grow Minnesota's energy storage industry by requiring and incentivizing the deployment of storage projects. Establish a goal of 3,100 MWs of storage by 2035 and direct the PUC to clarify interconnection rules for storage to encourage market growth. **(HF 1386)** 

**Clarify Net Metering Rules (Rep. Hansen) -** Solar deployment in Greater MN is plagued by a patchwork of differing interpretations of federal and state net-metering laws. Amending certain statutes to expressly require utilities to follow federal law and allow for standard dispute resolution processes will help further deployment of solar across Minnesota.

Advance Residential & Small-Scale Commercial & Industrial Solar - The small-scale distributed generation (DG) solar market is an important component of creating a more reliable, resilient, and secure grid. Funding core programs like:

- Solar for Schools program to decrease energy costs for schools across MN (Rep. Rehm)
- Solar on Public Buildings to lower energy bills for local & tribal governments (HF 747, SF 1404)
- Solar\*Rewards program provides a financial incentive for Xcel customers to install solar (**Rep. Hemmingsen-Jaeger/Sen. Mitchell**)
- Residential Solar Tax Credit to lower the cost for the average Minnesotan to install solar and storage at their home **(Rep. Bierman)**

MnSEIA also aims to prevent Homeowners' Associations from banning solar on single-family homes. **(HF 1262, SF 1003)** These initiatives will help build our 21st century grid while supporting MN businesses, growing jobs, and meeting the demands of Minnesotans.


**Improve Grid Infrastructure & Interconnection Process -** Expedite and streamline interconnection timelines by making targeted investments in grid infrastructure. **(Rep. Acomb)** 

**Develop Mid-Scale Solar Market -** The mid-scale (5-10 megawatt) segment of the solar industry in Minnesota is currently an untapped market ripe for investment. Establishing the rules for the DG market will help expand opportunities for solar businesses to thrive in the state.
